With reference to the subject mentioned above I have to inform you that the aforesaid writ petitions have been filed challenging the rules framed by the State Government i.e. Rule 8 of the Rules of 2017 for admission to Post Graduate Medical Courses in the State of Chhattisgarh. The Hon'ble Division Bench comprising Hon'ble Chief Justice Mr. T.
